### Director's Report:

Mr. Kleiman mentioned the previous meeting with Mayor Joshi who is receptive and supportive of ideas for the library in the future.

At the State of the Township dinner, the construction plans for the North Edison branch were on display and Mayor Joshi referred to them during his speech.

All drawings from the application are now on display in the Children's Room of the North Branch for staff and patrons to see.

The Menlo Park Mall experience was overall positive. The only negative was that the Library's branding was limited due to it being an information booth. The Library is looking at options to be there for summer reading. It was a good opportunity to build a relationship with the mall and the Library will be at the mall during Easter for storytimes.

Mr. Kleiman will be going to Portland for the Public Library Association Conference. He will be meeting with RFID and other vendors while there.

The final draft of the strategic plan is expected to be released to the Strategic Planning Committee. Hopefully it will come to the Board in April or May. Alan and Leslie Burger will be available to answer questions. It is an ambitious plan that, hopefully, will make the Library one of the centers of the Edison community.

Mr. Alcantara will be the Township point of contact for the Library in regards to the construction at the North Edison Branch.

### **Committee Reports:**

The Facilities and Bookmobile Committee did not meet last month.

This month the Financial Committee will meet.

The Materials Review Committee met. This committee reviews any concerns about library materials and the Collection Development Policy. A policy draft should be ready hopefully in April.

The Personnel Committee met to discuss the nonunion staff.
