## Director's Report:

Mr. Kleiman mentioned the Library followed up with the state as noted by Ms. Massey. Conversations with recipients of Round One of the grant funds usually say it's about nine months from when the application was done to get the project going. This means it could be June or July, the Library will follow up again next week. The committees did meet this month and the chairs will give a report.

Several staff will be attending the New Jersey Library Association Conference at the end of the month. Mr. Kleiman is doing a workshop based on the Age Friendly City Model from the World Health Organization (WHO). New Jersey is an age friendly state

and Mr. Kleiman hopes to get AARP more involved with the library. AARP is located in New Brunswick, so is local.

The state, as a part of the age friendly movement, is working with the NJ Council of the Arts as part of a pilot project. The Library received notification that it will be a test site for the creative aging model. There will be an artist in residence at the Library for four weeks in August.

The staff at the Main Library are preparing for the students' summer break.

Mr. Kleiman noted that Erin has been doing programs at Clara Barton which have been extremely successful and he hopes that Erin and Caroline, the new Young Adult Services Librarian, will be successful in finding activities for students after school from Thomas Jefferson Middle School.

The Library will be celebrating Juneteenth.

#### Committee Reports:

The Facilities and Bookmobile Committee met May 3<sup>rd</sup> and focused on renovation plans for the Main Library and pursuing some bookmobile options.

The Personnel Committee met on May  $2^{\mbox{\tiny nd}}$  and discussed the new administration position.

The Policies and Bylaws Committee met on May 3rd to discuss the volunteer application and is working on the bylaws.
